With reference to the previous circular, that the Central Animal House Facility at JIPMER is now registered with the Committee for the Control and Supervision of Experiments on Animals (CCSEA) and has received approval to conduct research, teaching, and training involving small laboratory animals such as rats, mice, rabbits, and guinea pigs. The facility also includes the infrastructure to breed rats and mice for research and teaching purposes. The Large Animal Facility is expected to be operational by the end of this year.

Departments may utilize the Central Animal House for the following purposes:

- Research: Efficacy and safety evaluation of drugs, medical devices, implants, and basic biomedical research.
- Collaborations: Inter-departmental or external collaborative research involving laboratory
- Training: Programs for students, research scholars, and technical staff.
- Teaching: Postgraduate education and training sessions.

To facilitate better awareness and utilization of these facilities, Heads of Departments (HODs) are encouraged to arrange a visit to the Central Animal House along with their faculty members.
