**Consolidated Pay** : Rs.25,500/- (per month)

**Age Limit**: Not exceeding 28 years as on closing date.

**Essential Qualification**:

- Matriculation with science as a subject from a recognized Board or equivalent qualification;
- 05 (five) years' experience in Central sterilization Department of Hospital/Medical Institute of repute.
- Desirable: Training in sterilization techniques from a recognized hospital/Institute.

**Reservation**:

Three posts are reserved for Open General (UR) category.

Candidates belonging to OBC/SC/ST may also apply for the above post if they are qualified and within the age limit as prescribed.

4. No TA/DA will be paid for the Written/Skill Test.
5. The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Department will issue TDS Certificate/s.
6. The contractually engaged persons will not have any claim for permanent or regular employment in this Institute as **this is purely a temporary contractual engagement** and will remain valid up to contractual period for which the engagement is approved on each occasion.
7. The contractually engaged persons will not be eligible to get official accommodation/quarters allotment within the campus as applicable to the other regular employees of this Institute.
