The candidates should bring the following original certificates with one set of self-attested copies.

1. Proof of Age (Birth Certificate/SSLC Mark Statement).
2. Relevant Educational Qualifications, starting from SSLC onwards.
3. Relevant Experience Certificate (if applicable)
4. Registration Certificate (if applicable)
5. Latest SC/ST/OBC/EWSs/PWBD Certificate obtained within a period of one year preceding the date of the Certificate/Biometric verification. If he/she belongs to OBC, the community certificate should indicate the status with reference to Creamy Layer as in the format issued by Govt. of India. (Certificates issued by the Competent Authorities, in the format prescribed in the Notice of the Recruitment in support of your claim to belong to OBC/SC/ST/EWSs/Ex-Servicemen / PWBDs categories)
6. Candidates shortlisted under Economically Weaker Sections (EWSs) to the posts as per the recruitment notification should submit the Income and Asset Certificate issued by the competent authority in the prescribe format i.e. Annexure-II as mentioned in the advertisement notification.
7. No Objection Certificate from the present employer (if applicable).
8. **If the candidate does not produce any of the above-mentioned documents in original along with self-attested copies of the same, he/she will not be allowed for further process under any circumstances.**
9. The list of shortlisted candidates are notified for biometric, certificate verification & skill test purposes only. Being placed on the shortlist provides no assurance that a person will be offered a job as the same is not the final selection list. The final Selection list shall be notified only after completion of biometric, certificate verification & skill test.
10. In case the candidates qualify under Persons with Disability (PwD) category, they have to undergo medical examination before the Medical Board constituted by JIPMER. **The decision of JIPMER Medical board will be final with regard to Persons with Disability.**
11. The candidate will have to bear travelling and other expenses for his/her journey to and from his/her place. No contribution will be paid by this Institute. This Institute does not also make arrangements for lodging and boarding for the candidates.
12. The candidature is provisional. He / She must, therefore, ensure that he/she fulfills all the conditions of eligibility laid down in the advertisement. To avoid any disappointment at a later stage, he/she is advised to recheck whether he/she meets all the eligibility criteria laid down as on the crucial date prescribed for the posts. i.e. 16.11.2023. If, at any stage, it is found that he/she does not fulfill any of the conditions of eligibility, his/her candidature will be cancelled and not appeal against such cancellation will be entertained.
13. No Individual call letter will be sent to the provisionally shortlisted candidates for appearing Certificate/Biometric verification & Skill Test.
