The Provisionally eligible candidates mentioned in **Annexure – III** should submit the relevant certificates as listed in the table against their name on or before **01<sup>st</sup> March 2019 (Friday)**

The eligible candidates should bring the following **original certificates along with one set of self-attested copies:-**

1. All **original Educational Certificates (from SSLC onwards), Latest Caste Certificates for SC/ST/OBC(Non-Creamy Layer) issued by Competent Authority, Experience Certificates & Registration Certificate with Medical Council of India** has to be produced, **failing which they will not be allowed to appear for interview.**
2. If the candidates belonging to **OBC category, they are informed to produce the latest caste certificate** issued by the Competent Authorities in the prescribed proforma in accordance with the Government of India, Dept. of Per. & Trg. O.M. No. 36033/28/94-Estt. (Res.), dated 02.07.1997, certifying that they **do not belong** to the **Creamy Layer** mentioned in column. No.3 of the schedule to the Govt. of India, Dept. of Personnel & Training, O.M. No. 36012/22/93-Estt.(SCT), dated 8.9.1993.
3. They are also required to submit a **clear experience certificate for teaching / research after obtaining the requisite educational qualification to the effect that the same will be treated as teaching / research experience in concerned discipline in case if it's not clearly stated in the application.**
4. Those working in Govt. / Semi. Govt. / Autonomous Bodies/PSUs, are also required to produce **Original copy of NOC from their employers** to the effect that the parent department does not have any objection to his/her applying for the job/to appear for interview for the above said post, **failing which, he/she will not be allowed to appear for interview.**
5. Individual call letters will be sent shortly through E-mail ID.
6. Request for Change of Interview Date & Skype interview will not be entertained.
7.
