Based on the scrutiny of applications for recruitment of Assistant Professor on contract basis for various Departments at JIPMER, the list of **eligible & provisionally eligible** candidates to appear for interview is enclosed as **Annexure 1**.

**The interview will be held on 29<sup>th</sup> & 30<sup>th</sup> March, 2023 through hybrid mode (in-person/online through video conferencing).** A detailed schedule regarding the interview for each Department will be issued shortly.

The candidates appearing for the interview are informed to submit an **option in the prescribed form (Annexure 2) regarding the mode of interview** to email ID: **jipmercf@gmail.com** by **23.03.2023 (Thursday), 4.30 PM**. Option form once exercised shall be final and no request for change will be entertained. In case of no response is received from the candidate within the stipulated time, the mode of interview will be treated as in-person.

**For Candidates who opt for interview through videoconferencing**, a video link and tentative time slot will be informed to the candidates at their registered email id mentioned in the application form, 1-2 days prior to the interview.

*The eligibility of the candidate at this stage is purely provisional and the candidate being merely adjudged as Eligible/Provisionally eligible does not confer any right on him/her being selected for the post. If at any time during the selection process (or) at the time of verification of original certificates/documents, it comes to the notice that a candidate has filled wrong entries/does not possess the required qualification as per the Recruitment Rules for the post, he/she will be treated/declared as Not eligible and his/her candidature/selection will be treated as cancelled. Decision of the competent authority of JIPMER is final in this regard.*

In case of any objection/clarification (if any) by the applicants found **not eligible** regarding his/her eligibility, **he/she may send the objection/clarification along with relevant document(s)/justification by email to jipmercf@gmail.com on or before 23.03.2023 (Thursday), 4.30 PM**. The objections/clarifications received after 4:30 PM on 23.03.2023 will not be considered.
