Sub: Health Care Professional Registration of Newly Joined Doctors

National Health Authority, Ministry of Health and Family Welfare, Government of India has mandated compulsory registration of all the doctors with MBBS qualifications and further specialization to register in the health-care professional registry of the Ayushman Bharath Digital Mission (ABDM). All residents and doctors who are joining the Institute are therefore required to register in the healthcare professional registry of ABDM and declare their place of work as JIPMER. The procedure for registration is as follows.

2. URL is <https://hprid.abdm.gov.in/register?origin=NDR> for new registration and <https://hpr.abdm.gov.in/en/users/login> verification of existing registration. The process would require Aadhaar linked mobile number, uploading scanned PDF/JPEG files of all medical qualifications, medical council registration certificate and appointment order or pay slip. The maximum size of each scanned copy is 1 MB. While declaring the place of work, JIPMER must be declared as health care facility with facility ID **IN3410000430** for **JIPMER Puducherry** and **IN3410000584** for **JIPMER Karaikal**. The name of the Institute must be typed in full as “Jawaharlal Institute of Postgraduate Medical Education and Research” and not as acronym JIPMER.

3. The doctors may take the help of Data Processing Assistant Mr. D.Ramkumar (mobile - 9591884194 and Email – msdramkumar@gmail.com) and Data Processor Mr. N. Sivarajan (mobile - 9500716288 and Email – sivarajan.natarajan@gmail.com) in IT wing to facilitate their registration as health-care professionals.

4. This registration as a healthcare professional is required for processing the salary for all the newly joined residents and doctors and hence may be complied with on priority to avoid delay in processing of salary.
