**Open Tender Notice Inviting Auction for Disposing of Hospital Condemned
Linen items - reg.**

Please quote your highest rates (Per Kg) for disposing of hospital condemned linen items as per the list attached in Annexure- I

Subject to the following terms and conditions:

1. The bidder will have to quote one rate in Indian Rupees/kg that, he/she is willing to pay for the hospital condemned linen.
2. 5% GST will be charged to the buyer. Any other Government Tax/levies applicable at the time of the delivery will be borne by the purchaser/ Buyer.
3. No insurance charges are payable as per the rules in the Government. As such, the firms before quoting should take into consideration all the risks in the transit and furnish tender which should cover insurance charges also. If any point is raised as regards insurance charges after orders are issued, the same will not be entertained from the firms thereafter.
4. Rates should be quoted for one kg of condemned linen. No extra charge will be paid by JIPMER towards extra packing, and forwarding charges etc. should not be quoted. Loading/unloading of the material will be done by the purchaser at their own expenses.
5. Delivery will be made in actual weighment basis.
6. The Purchased/Buyer will first carry out the work of tearing the condemned linen items in pieces before weighing the same in presence of concerned officials of JIPMER.
7. The bid may be valid for a period of One year (1 year) from the date of issuing the supply/work order from JIPMER.
8. The Director shall have the right of rejecting the quotations in whole or part without assigning any reason therefore.
9. JIPMER Employees are not allowed to participate in Tender.
10. Inspection of condemned linen items can be done in Department of Laundry during office hours on working days.
11. All disputes pertaining to the tender will be subject to Puducherry jurisdiction.
12. Open tender should be sent only by register post or speed post or courier. Hand quotations are not accepted. Please furnish your tender in a sealed cover.



7. The appropriate amount against the weight approved by JIPMER, shall be paid by the vender at Cash Section, JIPMER and the receipt to be submitted to Department of laundry before removal of condemned linen.
